Goal of the document

This document describes the technical specifications of the web service of the BELparcel platform of the NSSO/BIPT.

The document describes the context, the terms of use, the functionalities and the actions (request and response) of the service. For each type of message examples will be provided along with the possible error codes that can occur.

This webservice was created to allow companies to comply to the Parcel Delivery Act of 17 December 2023. With the help of this document, their IT department will be able to correctly integrate with the NSSO/BIPT BELparcel web service.

BELparcel Reporting Requirement

The aim of the Parcel Delivery Act of 17 December 2023 is to improve working conditions for couriers (parcel delivery workers) and to establish sustainable competition between parcel delivery service providers operating in the parcel delivery sector.

Each registered company has the obligation to report on its delivery activities every six months. Starting with the period from 1st of July 2024 to 31st of December 2024. The company is given until maximum a month after the end of the half-year period to send their report (respectively on the 31st January and 31st July).

The company must report the following information for the previous half year in the BELparcel online service:

- Name and contact details of the mandatory coordinator and any transport manager or holder of the transport manager's certificate of competence.
- The number of parcels delivered per direct subcontractor and the fees paid for these parcels per subcontractor. If the company is a subcontractor, the number of parcels and the amounts invoiced per principal.

- The addresses of all distribution centers.
- A brief description of the services provided.

General Functionality of the webservice

Available operations

The NSSO/BIPT offers a REST Web Service which allows companies (or their mandatory) to send a half yearly report.


The following operations are available:

- Save and send a report: POST /reportsPOST /reports: Save and send a report
- Retrieve reporting periods: GET /periods
- Retrieve a specific report by its reference: GET /reports/reference
- Retrieve all the reports of a company: GET /reportsGET /reports: Retrieve all the reports of a company

Report

A report consists of the following

- Report: contains the general information such as the technical reference of the report, the status, ...
- Period: the period for which the activities of the company are being reported. This contains the dates of the reporting period as well as the dates between which a report can be submitted.
- Remunerations: list the number of delivered parcels and the fees received/given for each direct subcontractor and principal of the company
- DistributionCenters : An array with the address information of each distribution center of the company
- ContactDataList : An array with the contact information of each contact persons responsible for deliveries in the company
- ProvidedServices : General information on the type of services the company provides



The "Period" section of the report is automatically generated by the BELparcel application.

Report Submission

Report Submission Flow

In order to be able to send a Report the company must first be registered. If the company has not yet been registered, this should be done first. More information on this process can be found here <https://belparcel.be/en/which-obligations/registration-company.html>.

At the start of each reporting period or when a company becomes registered, an empty report is automatically '*initiated*' for each registered company. This report can be retrieved using the GET /reports method.

This initiated report can be updated and submitted using the POST /reports method. The period for which the submission is done depends on the content of the period object provided in the body, more specifically it is derived based on the value of the *startYearMonth* property. Info on periods can be retrieved using GET /periods.

An intermediate version of a report can be sent with the status 'draft' until the end of the period. Once the report is considered complete, it can be sent with the status 'submitted'. Multiple submissions are allowed, and each new submission will overwrite the previous version of the report. A 'submitted' report can only be submitted after the *submissionStartDate* (*report_period.submissionStartDate*)


Since the report is overwritten it is important that the complete report is provided in each call to the POST /reports method.

Attention, reports that do not have the status 'submitted' by the end of the reporting period are not considered as valid reports.

In special cases, and upon request to BIPT, the report can be 'reopened' by BIPT. This allows a company to make modifications and resent the report. The must then be sent again with the status 'submitted'.

For each report submitted with the status 'submitted', the BELparcel application will send a confirmation of receipt via eBox.

A **remuneration** contains the information of the total fee, amount of parcel and role of the companies who acted as principal or subcontractor.

Description of endpoints

POST /reports

This operation enables the company to send a specific report. The request body of the call should contain the full content of the report.

If a report has already been previously submitted previously sent, this call will overwrite the existing data with the new information provided. So it is important that for each POST call the full object is provided.

Request Body:

The *report*, *period*, *remunerations*, *contactDataList*, *distributionCenters*, and *providedServices* objects are to be provided for each call. However, not all data within these objects are required. More information below

Period:

This period is necessary for BELparcel to identify and verify that the correct report is being sent. This information can't be updated by the POST call.

- If a period is **open**, it indicates that a report for this period can still be sent.
- If a period is **closed**, it means the reporting period has ended, and any reports linked to it can only be consulted.
